- A student must be eligible by September 1, 2026 for the grade level according to the age listed in the fee schedule above.
- A student is not enrolled until Christ Church Preschool has received and processed all application materials, including the online Procure account registration (for new families), the non-refundable deposit fees¹, and the signed enrollment contract. Once these three steps have been completed, your application becomes a binding contract for the full 2026-2027 school year.

¹ A non-refundable, non-transferable deposit of \$600 (i.e., \$325 tuition deposit², \$100 enrollment fee, and \$175 supply fee) is due at the time of registration. A one-time, non-refundable, non-transferable new student fee of \$50 is required with the deposit for all new students invited to enroll.

The tuition amount listed above reflects the reduction of the tuition deposit and is the remainder due for the course of the selected payment plan. Incidental expenses incurred during the school year (e.g., extended day, spirit shirt, enrichment, etc.) are added to your Procure account and billed monthly to the selected payment method. All accounts are due upon receipt of the statement.

- Christ Church Preschool uses Procure, a free online portal for you to access account information and easily pay tuition payments through automatic payments. Procure uses *Tuition Express®* for payment processing, allowing secure payment to be made from your credit card or bank account using one of the payment plans outlined above. Processing fees, if applicable, are not refunded when any refund is made. Any refunds will be returned via a business bank check.
- Submission of a current School Entry Health Exam (Form DH 3040) and Florida Certificate of Immunization (Form DH 680 only) is required of all students in accordance with State regulations. The School also needs a

copy of each child's birth certificate. **Forms must be received by the first tuition payment.** (Current students' records are on file and do not need to be resubmitted unless notified by records@preschoolcec.org.)

- Christ Church Preschool offers an Extended Day Program for currently enrolled students in accordance with their enrollment schedule. Early Risers begins at 7:30, while after school care is offered depending on the grade level of the student. Please contact extday@preschoolcec.org for more information.
